- submitting your details to clients
- managing our databases and records
- arranging payroll, payments, statutory entitlements and benefits
- complying with legal and regulatory obligations

- improving and developing our services

2(b). Legitimate Interests

Where we rely on legitimate interests, these include:

- requesting consent where required (e.g. marketing communications)

3. Data Retention

- Payroll, tax, holiday pay, SSP and pension records: 3–6 years, in accordance with HMRC and
- employment legislation
- Retention periods may vary depending on legal or contractual obligations.
